Definitions of Vegetation Strata:

Sapling/Shrub - Woody plants less than 3 in. DBH, regardless of height.

Herb - All herbaceous (non-woody) plants, regardless of size.

Woody Vines - All woody vines, regardless of height.

Remarks: **The wetland is a shallow marsh community in a depression. There are willows in a thin fringe around the edge of the basin and trees growing on the upland slopes overhang the wetland. Hydrophytic vegetation is present.**

Additional Remarks:
The general area appears to be an old gravel pit with swales and ridges (pits and spoils) throughout, wetland communities are present in the swales.
