Dear Mr. Storkamp:

On September 9, 1998, the Minnesota Pollution Control Agency (MPCA) staff was notified that a release of petroleum occurred from storage tank facilities that you own and/or operate at the site referenced above.

A recent review of our files indicates that we have not heard from you whether you intend to investigate and if necessary, clean up the petroleum contamination at this site. We again ask that you respond verbally or in writing to this letter and describe the status of your investigation and/or cleanup, or explain why no action has been taken. You must respond within 30 days of receipt of this letter. Failure to do so may result in reduced reimbursement from the Petrofund and/or enforcement action taken against you by the MPCA.

If you have questions regarding the actions requested by the MPCA, or if you conclude that the release is not from any tank which you have owned or operated, please call me at (218) 828-6118. Otherwise, I look forward to receiving your reply.

If you have not already done so, we recommend that you hire a qualified consulting firm registered with the Petro Board that has experience in conducting petroleum release site investigations and in proposing and implementing appropriate corrective actions. A list of registered contractors is available from the Department of Commerce. Please note that, under Minn. R. 2890 (Supp. 1997), you must solicit a minimum of two competitive proposals on a form prescribed by the Petro Board to ensure that the consulting costs are reasonable. Please refer to MPCA fact sheets for information regarding the scope of investigations required at petroleum release sites. MPCA staff requires that the site investigation fully define the extent and magnitude of soil and ground water contamination caused by the release. 
