I am writing to inform you that actions have been taken to investigate contaminated soil and/or ground water at sites in your district. The sites are Hallock Elementary School at 411 South Fourth Street and Hallock High School at 444 North Ash in Hallock. As allowed by the Petroleum Tank Release Cleanup Act, the responsible party has applied to the Minnesota Petroleum Tank Release Compensation Board (Petro Board) for reimbursement of 90 percent of their cleanup costs up to \$1,000,000.

On July 11, 1991, the Petro Board voted to reimburse Hallock Elementary School \$14,943 and Hallock High School \$15,155 in repayment of cleanup costs.
