## Nancy,

In regards to the soil disposal (110 cubic yards PRP, 180 cubic yards BRP) at the South Central Grain & Energy site in Hector, we have been in steady contact with Renville County engineer Marlin Larson over the last year to dispose of the soil in the Renville County landfill. After many conversations regarding how this could work for everyone involved, we have only recently found out that Renville County will no longer accept the soil.

Marlin cited the lack of space during the construction of a new cell, weather delays in construction and the fact that the landfill would not be able to accept the soil prior to the September 30 deadline. I have attached the email from Marlin.

For the past three months I have been contacting land farmers listed on the MPCA website in an effort to have a backup plan for disposal. I have exhausted the option of landfarming the soil as there are no landfarming sites that are either willing to take the soil or are allowed to take the soil due to local government restrictions. I have contacted landfarming sites in the cities of Cottonwood, Jackson, Lakefield, Fairmont, Good Thunder and Pipestone.

In addition to the Renville County landfilling and southern Minnesota landfarming options I have made contact with thermal treatment facilities and two additional landfilling sites near the Twin Cities (Buffalo and Glencoe). Both thermal treatment facilities contacted have not returned any phone messages left. The other landfill sites are in the process of providing proposals to accept the soil.

We are seeking approval to landfill the soil as other options have been exhausted. Based on conversations with the landfills and hauling companies we anticipating disposing of the soil by the 13th of August barring approval.
