Hi Tony

Based on our discussion, I have revised our proposal requesting Renville County Landfill be approved to accept a large quantity of contaminated soil from a site in Hector, Minnesota. As requested, the proposal has been modified to only allow long-term storage in the Demolition Debris Landfill for the petroleum contaminated soil since no DRO was detected in 2011 samples. Any fertilizer contaminated soil accepted would be placed on the MSW liner until it is used. For both types of contaminated soil, we are requesting to store it over the next several years until it is completely used up as intermittent and intermediate cover within the MSW landfill only.

We hope to start hauling soil in August to allow us to seed the stockpile before the end of summer. Let me know if you have any questions.
